BVCA PARTNERSHIP'S WEATHERIZATION PROGRAM TO RECEIVE ADDITIONAL FUNDING

New sources of funding have Blue Valley Community Action Partnership's Weatherization Program poised to help more clients than ever before.



BVCA is set to receive \$1.8 million over the next five years in new funding for Weatherization, as part of the bipartisan federal infrastructure bill passed in 2021. "We refer to it simply as 'bill money," Weatherization Manager Brandon Bonar said. The new funding will be disbursed in intervals and push BVCA's annual program budget to approximately \$850,000 per year. he estimated.

BVCA Weatherization took steps increase its capacity to serve clients in advance of this increase to the program's budget. Bonar said, "We saw it coming, so we scaled up." Additional crew members were hired and trained, giving BVCA two inhouse crews at its disposal.

Bonar estimated BVCA can weatherize 144 more houses in the next five years thanks to the bill money, once administrative and training costs are taken into account.

Along with the infrastructure bill, weatherization programs also now have access to what Bonar called readiness funding. Crews can now spend up to \$4,000 on top of what would normally be spent on a project to address issues that might otherwise disgualify a property from being eligible for weatherization. He cited a poor roof or leaks as examples of problems that can now be addressed.

Weatherization carries no cost to clients and is available to both homeowners and renters who meet income qualifications. Depending on the work that needs to be done, landlords may be responsible for a portion of the project's cost. Along with drastically increasing the affordability of heating and cooling a home, weatherization also makes the property safer and healthier for occupants. Each project carries a life expectancy of 10 years.
